Quotes are valid for 60 days from the date stated above unless otherwise advised. Quotes are based on customer provided measurements and are subject to change upon WMGT template measurements having been submitted and received. If there is a +/- 2-square-foot measurement difference between the customer-provided measurements and WMGT template, a revised quote will be processed. Removal of existing countertops, plumbing and electrical, or repairs/adjustments of existing cabinets are the sole responsibility of the customer. Surfaces/areas to receive stone must be ready for installation; otherwise, additional charges will be applied to reschedule the installation. Seams indicated by a dotted line are determined at template/site visit and are subject to change at WMGT discretion, which includes but is not limited to adding or removing placement of a seam upon the site visit.

Installation dates will be booked once the site measurements have been completed by the templator and all information and materials (e.g. sink, faucet, cooktop, etc.) are provided. Delays in production may occur if material is not in stock. All stone is subject to inspection and approval by WMGT. Any work not described above will not be performed without additional charges.

Payment terms:

A deposit of 75% must be paid prior to template. Final payment is due upon completion of work (day of installation) and will be charged to the provided credit card information on the signed Credit Card Authorization and Consent Form. Late payments on delinquent amounts are subject to 2% per month, compounded monthly (26.82% per
